

FEES & SCHOLARSHIP POLICY

1. Policy Statement

Umeed Global School is an international-standard residential (boarding) institution committed to nurture knowledgeable, character and purpose-driven leaders from diverse socio-economic backgrounds, guided by Islamic principles of justice, equity, compassion, trust and social welfare.

This policy establishes a transparent, fair, and sustainable fee and scholarship framework aligned with global best practices while upholding Islamic moral values.

2. Policy Objectives

The objectives of this Fees & Scholarship Policy are to:

- A. Ensure equal access to the same high-quality education, facilities, curriculum, and care for all students, irrespective of whether they come from affluent or economically weaker backgrounds.
- B. Uphold the principle that privileged and under privileged students study together under identical academic standards, infrastructure, discipline and learning opportunities, promoting inclusion and education equity without discrimination of any kind and ensuring that financial status does not create educational segregation.
- C. Provide structured financial assistance through scholarships to orphans, disadvantaged and meritorious students
- D. Encourage community participation and social contribution by financially capable families.

3. Seat Allocation Framework

To balance inclusivity and sustainability, admissions shall be allocated as follows:

- A) **70% Seats – Scholarship Supported (Merit + Need Based)**
Sponsored by the School Board, covering School fees in income-based categories.
- B) **30% Seats – Full Fee Paying (Merit Based)**
Parents under this category shall pay full School and Hostel Fees

4. Income-Based Scholarship Categories

Eligibility for scholarships shall be assessed annually based on verified household income and supporting documentation.

Category 'A' – Economically Weaker Section (Reserved for 15% Seats)

Monthly Family Income: Below Rs. 20,000/-month

- a) **Scholarship Coverage:** School Fees + Hostel Fees (Admission Fee, Session Fee, Tuition Fee, Lab. Fee, Exam Fee, Maintenance Fee, Excursion Fee, Accommodation Fee, Laundry Fee, Sports Fee, Care & well Fee etc.)
- b) **Scholarship Amount : Rs.1,00,000.00 (From Class I -V)**
- c) **Scholarship Amount : Rs.1,07,500.00 (From Class VI -IX)**
- d) **Fees Payable:**
 - o **Mess Charges :** Rs. 12,500/- per quarter
 - o **Annual Payable:** Rs. 50,000/-

Category 'B' – Lower Income Group (Reserved for 20% Seats)

Monthly Family Income: Rs. 20,001/- – Rs. 30,000/-month

- a) Scholarship Coverage: School Fees + Hostel Fees (Admission Fee, Session Fee, Tuition Fee, Lab. Fee, Exam Fee, Maintenance Fee, Excursion Fee, Laundry Fee, Sports Fee, Care & well Fee etc.)**
- b) Scholarship Amount : Rs.80,000.00 (From Class I -V)**
- c) Scholarship Amount : Rs.87,500.00 (From Class VI -IX)**
- d) Fees Payable:**
 - Mess Charges: Rs. 12,500 per quarter
 - Accommodation Fee: Rs. 5,000 per quarter
 - **Annual Payable:** Rs. 70,000/-

Category 'C' – Middle Income Group (Reserved for 35% Seats)

Monthly Family Income: Rs. 30,001 – Rs. 50,000

- a) Scholarship Coverage: School Fees (Admission Fee, Session Fee, Tuition Fee, Lab. Fee, Exam Fee, Maintenance Fee, Development Fee, Excursion Fee, etc.)**
- b) Scholarship Amount : Rs.55,000.00 (From Class I -V)**
- c) Scholarship Amount : Rs.62,500.00 (From Class VI -IX)**
- d) Fees Payable:** (Hostel Fees- Accommodation Fee, Laundry Fee, Mess Charges, Sports Fee, Care & Well-being Fee, Maintenance Fee)
 - Class I – V: Rs. 95,000 per annum
 - Class VI – IX: Rs. 97,500 per annum

Category 'D' – Full Fee Paying Category

Monthly Family Income: Rs. 50,000/-month and above

- a) Fees Payable:**
 - Class I – V: Rs. 1,50,000 per annum
 - Class VI – IX: Rs. 1,57,500 per annum

School Support Fees:

Parents with annual income exceeding Rs. 10 Lakhs shall pay an additional Rs. 50,000/- or more per annum towards the School Support Fees.

Exception & Seat Reallocation:

Notwithstanding the above allocation, where all seats under Category 'A' (Economically Weaker Section) are fully filled and vacancies remain in Category 'B' and/or Category 'C', eligible candidates originally qualifying under Category 'A' may, at the discretion of the School Management, be considered for admission against such vacant seats in Category 'B' and/or Category 'C' as per the respective fees and scholarship policy.

However, candidates qualifying under Category 'B' or Category 'C' shall not be eligible for consideration against Category 'A' seats under any circumstances.

This exception is intended solely to optimize seat utilization while preserving the priority and protection afforded to Category 'A'. The decision of the School Management and Admission Committee in this regard shall be final and binding.

Scholarship Disbursement Statement:

In line with its mission to nurture talent without financial barriers, **Umeed Global School** is awarding Scholarships totaling **Rs. 5,02,50,000.00** (Rs. Five Crore Two Lac Fifty Thousand only), distributed as follows:

5. Staff Welfare & Fee Concession Policy

In recognition of the dedication and service of School staff members, the following concessions shall apply:

One (1) child of a regular staff member studying or admitted to Umeed Global School shall be provided 100% fee exemption, including School and Hostel Fees.

Second child onwards shall be charged strictly as per the applicable income-based category (Category A-D).

This benefit applies only during the active period of service of the staff member.

6. Allocation of Special Category Seats

Distinguished Individuals Category (5%)

5% of the sanctioned intake shall be allocated under this category to recognize excellence in religious scholarship, education, institutional leadership, and social contribution.

This may include:

- a. Huffaz-e-Qur'an and students pursuing Hifz alongside formal education
- b. Children of heads or senior functionaries of recognized educational, charitable, or social institutions
- c. Children of individuals with distinguished contributions in education, scholarship, social service, or community leadership

Management Quota Category (5% in Each Class)

An additional 5% of the sanctioned intake shall be allocated under the Management Quota Category, at the discretion of the School Management.

Admissions may be considered on recommendations from:

Members of Parliament, Members of Legislative Assemblies, or Local Body Representatives Officers of Civil Services including IAS, IPS, and other notified executive services District Education Officer or other competent education authorities

Governing Provisions

These categories are non-statutory and non-caste-based and shall not be construed as reservations under constitutional or statutory law.

All admissions shall be subject to minimum eligibility criteria, availability of seats, and approval by the Competent Authority of the School.

The School reserves the right to regulate, revise, or discontinue these categories in accordance with applicable law and institutional policy.

Governance, Review & Compliance

- A) Fees and scholarships shall be reviewed periodically by the School Management Committee.
- B) Income verification documents are mandatory for all scholarship categories.
- C) Any false declaration shall result in immediate withdrawal of concessions.
- D) The School reserves the right to amend this policy in line with regulatory, financial, or institutional requirements.

Approval

This Fees & Scholarship Policy is approved and adopted by the School Management Committee of Umeed Global School and shall come into force with immediate effect.
